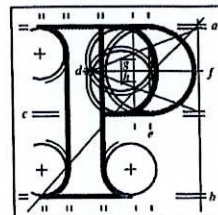

**BusConnects Templeogue / Rathfarnham to City Centre CBC proposals and planning application  
Impact on Rathfarnham Castle Park**

Dear Sirs,

I would like to object to the proposal to widen the Grange Road substantially by taking up to 10 metres of the Woodland area of Rathfarnham Castle Park. The Woodland is a very important amenity for many people, especially autistic children, for whom it is a calming, regulating environment. It has a fantastic range of wildlife, especially protected wild birds, bats, frogs, bees, ducks and squirrels. It is a calm, peaceful, natural play space with a wonderful Woodland Playground. My own children love this area.

I wish to object on the basis of the following:

- 1. Excessive Land Take** – I understand that “up to 10 metres” of woodland area is set to be built over for road widening purposes. However the existing road is over 15 metres wide and does not need to be widened by up to 10 metres. That is clearly excessive and unnecessary. While outbound buses should be prioritised, this can easily be done without impact on the Park by means of a signal controlled priority light at Butterfield Avenue.
- 2. Environmental** – the Park is a diverse habitat for a wide variety of wild birds and wildlife, almost like a small nature reserve. Although it will be significantly impacted by the proposed road widening works, it has not actually been surveyed in relation to most of the wildlife for whom it is a breeding habitat. It is a very successful breeding area especially for frogs, bats, squirrels, tufted ducks, and mallards. It should be appreciated as a peaceful wildlife habitat, not turned into a construction site as that will cause it to no longer be a successful breeding habitat for these protected species.
- 3. Importance for autistic and neurodiverse children** - The Woodland contains a great many mature trees, bushes and undergrowth and it has a sense of being out in the countryside, rather than right beside Rathfarnham Village. Many autistic and neurodiverse children love this area from a sensory perspective and find it a very calming area. It is a peaceful natural play space which is totally different from the usual playgrounds found in parks.

## **Conclusion**

I would submit that the proposals to widen the Grange Road over a substantial part of the Woodland area of Rathfarnham Castle Park are excessive and entirely unnecessary. Once outbound buses are prioritised with a signal controlled priority light at Butterfield Avenue, the remainder of the >15m roadway is sufficient for the inbound bus lane, two general traffic lanes and pedestrian and cycling facilities. This area is so important for both wildlife and children, especially autistic and neurodiverse children. Unnecessarily destroying up to 10 metres of a serene woodland habitat and peaceful natural play space would be entirely inappropriate and unacceptable.
