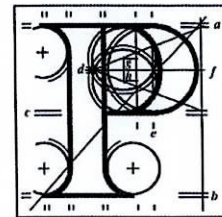

1. We object to this scheme in the strongest of terms.
2. Victoria Road will become a rat run for all driver s avoiding the no turn restrictions at Wasdale and Glenayre.
3. There is a complete lack of clarity about how we get access to Rathmines and into Dublin City, Terenure and M50.
4. Our bus connect route has the most complex issues as our roads are narrow with a failure to understand local dynamics.
5. The outrageous and environmental unsound decision to remove trees in Terenure Road East.
6. Rathgar traffic in the village will be unbearable at the crossroads. This will impact local businesses and result in more cars and is environmentally unsound
