

Submission re Templeogue/Rathfarnham to City Centre Core Bus Corridor Scheme and

Proposed plan for Highfield Road

To An Bord Pleanála Board,

As a Rathgar resident, the streetscape and public realm of the Rathgar area are a quintessential part of its makeup. It is an historic urban village and an important part of the fabric of Dublin.

I am a member of the Rathgar Association residents and therefore I agree with everything already submitted by the Rathgar Residents Association.

My additional points concern mostly Highfield Road:

The proposed plan will transform Highfield Road into the main access road to Rathgar from the city centre. Already, Highfield road in impracticable at rush hour as I cannot take a large amount of traffic. The proposed plan will therefore lead to major congestion and major pollution on the road due to the congestion.

It will become dangerous for residents and their children to cycle on Highfield road. Highfield road is too narrow to accommodate a cycling path. As a result, residents who cycle, which is a great mode of transportation, will have to negotiate a road blocked by traffic and bus corridors, all of which on a narrow road. Residents will have to give up cyclin, particularly when they have children, which is hardly a beneficial effect.

The congestion resulting from the proposed plan will affect traffic going in and out of St. Luke's hospital, making it awkward for staff and patients to access the hospital and delaying ambulances going in and out of the hospital. This is inacceptable as it could jeopardize the care of very ill patients since the hospital is one of the main oncology hospitals in Dublin.

The proposed plan includes 2 new bus corridors on Highfield Road. Part of the road is extremely narrow and as a result, the pavement in some parts of the road is barely wide enough to allow prams to navigate it safely. 2 people walking together ca not walk on the pavement side by side. Having buses on the road will lead undoubtedly to fatalities and

people will get injured. It is unsafe. I doubt very much that the width of the sidewalks has been measured while developing the plan.

A lot of people work remotely since Covid and the need for massive bus connections is outdated. Many other cities now favour other means of transportation, which are more in tune with our new ways of living and working.

Overall the current plans overburden Rathgar village and surrounding roads with an increase of bus frequency which will be detrimental to the liveability of our village and area. The NTA's insistence on routing all buses from Templeogue/Tallaght and Rathfarnham through Rathgar Village puts a disproportionate burden on Rathgar (and on Rathmines). These bus routes could have easily been separated with a bus service interconnection in Terenure Village and separate bus services along Terenure Road East (towards Rathgar) and, alternatively, along Terenure Road North and Harolds Cross Road. Indeed, the interconnection of bus services lies at the centre of the Busconnects ethos so it is very difficult to understand the proposal to route all those buses along one route only (through Rathgar).

BusConnects' plans propose a total change in the dynamic of these roads, in particular Highfield Road which will now see an increase of traffic and the introduction of a new Orbital bus route. Many other side streets in our area will suffer devasting knock on effects including increased traffic, increased emissions due to congestion, one way systems and increased dangers to pedestrian and cyclists on smaller roads.

It has always been clear that a comprehensive underground metro would allow Dublin's residents, commuters and visitors to access the city and its environs whilst saving Dublin's environment, built heritage and special character. The introduction of school buses would also make a vast improvement to the lives of both families and residents across Dublin.

The traffic going in and out of St Luks's hospital will be greatly affected, penalizing both staff and cancer patients attending the hospital. This is not acceptable.
