




Dear Sirs,

With reference to the above I wish to make the following observation:

To create the proposed bus corridor it appears that it is intended to remove 34 mature and very mature trees and one hazel thicket from the Templeogue Road side of Bushy Park, [Map 1099(4).1f] and a further 94 mature and very mature trees, from the Rathdown Drive/Rathdown Crescent section of Templeogue Road [Maps 1099(2)1h and 1099(3)1h] These trees include interalia oak, ash, chestnut, sycamore, rowan, lime and cherry. My layperson's estimate of the age of at least one of the horse chestnut trees, in which a pair of Mistle Thrushes happily reside, is in the region of 100-200 years old.

I find the proposal incomprehensible for a number of reasons.

- 1. Trees reduce pollution caused by road traffic, by storing pollutant gases emitted by traffic; and by photosynthesis, they release oxygen. This is the primary essential component required for human and animal survival. The proposed plan to remove those trees in order to add further pollution by increasing bus traffic is contrary to all known evidence of the effects of pollution on global warming, and on human, animal, bird and insect life. It is noted that electric vehicles cause less emissions, but they do cause emissions.
- 2. Going from Terenure towards Templeogue Cross, the road reaches the section at the junction with Fortfield Road, where it appears from the maps that it is not intended that it be widened. This means that the proposed bus corridor suddenly merges with other traffic, thereby causing a

- 2. Going from Terenure towards Templeogue Cross, the road reaches the section at the junction with Fortfield Road, where it appears from the maps that it is not intended that it be widened. This means that the proposed bus corridor suddenly merges with other traffic, thereby causing a

- bottleneck just at the point where it approaches the Templeogue Crossroads. The benefit is unclear.
- 3. The proposal to CPO the areas containing trees, as designated on the deposited maps is in effect a proposal to take what are public spaces. While these spaces may well be legally owned by Dublin City Council, they are effectively held in trust for the benefit of the public which is served by the same City Council. As a member of the public I strongly object to the Compulsory Purchase of these lands by the National Transport Authority.

It is possible for an alternative plan to be made.

The objective of the Scheme is stated to be: 'to provide improved walking, cycling and bus infrastructure'. It is submitted that construction of infrastructure cannot be the sole objective. Account must be taken of the health of the users, and of the protection of the biodiversity, including plant, animal, bird and insect life. A mature tree can support thousands of different species of birds, insects and animals. These creatures, together with cyclists and pedestrians, need to breathe.

My suggestions are:

At Bushy Park:

- 1.1 Create a cycle lane beside the existing footpath within the park. There is no need to destroy trees to do this. If there is a tree partly in the way of the proposed path, go around it.
- 1.2 LEAVE THE TREES AS THEY ARE growing, transpiring, and supporting and contributing to the health and well being of the community, as they have done for many, many years.
- 1.3 Let pedestrians continue to use the existing park pathway.

At the Rathdown Park section:

- 1.4 Let cyclists and pedestrians use Rathdown Drive (as they currently do).
- 1.5 At the Terenure end of the Rathdown Drive section it may be necessary to compulsorily purchase a small section of one side or the other (possibly between Rathdown Park and Terenure Cross, and either from existing gardens on the Fergus Road side, or from the sports ground on the Lakelands Park side).
- 1.7 Make the highway for bus use only.
- 1.8 Divert other vehicular traffic.
- 2 If this proves not to be possible, PLEASE consider the Compulsory Purchase of part of the properties on the far side of the road. There are some trees, but not so many would be destroyed.

But please do not destroy thousands of years worth of growth with the result being to further pollute the environment.

Alleged progress is not everything. Travelling more quickly or more efficiently towards what is ultimately our end, should not be the goal.
