

Re: Templeogue/Rathfarnham to City Centre Bus Corridor Scheme

Dear Sir/Madam

I am a resident of Lissenfield, Lr Rathmines Road, Dublin 6. Lissenfield is a residential development located on the western side of Rathmines Road Lower to the north of its junction with Military Road. It is a cul-de-sac development of 57 units housing approximately 100 residents. The only pedestrian/cyclist/vehicular access to the development is via entrance on Lower Rathmines Road.

I have serious concerns about the installation of a Bus Gate on the road so close to the entrance to Lissenfield which will prohibit right turning movements from the development.

I volunteer as a delivery driver for Meals on Wheels in the area for the past 10 years. Our meals are prepared in St. Mary's Community Centre behind the church on Lower Rathmines Road. Currently I turn right onto Rathmines Road and then left onto Richmond Hill to access the Centre. This will no longer be possible and I can see no way to do this other than taking a tour to Harold's Cross and back which contradicts the whole concept of Bus Connects to take motorists off the road and help the environment. We delivery approximately 25 meals daily Monday to Friday thus providing an essential service which is in danger of being eliminated by Bus Connects.

The community we deliver to are vulnerable people. living alone who depend on these meals as their sole source of hot food and in some cases their only social contact. Many of these people live in Mount Anthony in Rathmines.

For this reason I suggest the Bus Gate be either removed from the proposed site to facilitate a right turn from Lissenfield or not operate between the hours of 10.00 and 14.00 Monday to Friday to facilitate a continuation of this valuable service in the area.

I enclose a cheque in the amount of Euro50.
