

To whom it concerns,

We are residents of Rathgar Village and are writing to object to the National Transport Authority's application for a proposed road development consisting of the "Bus Connects" Corridor for Templeogue/Rathfarnham to the City Centre which travels through Rathgar Village and has very significant implications for Rathgar Village and the surrounding areas.

The consultative process lacks any sense of fairness and democracy. The involvement of City and County Councillors in the Bus Corridor process seems to have been completely disregarded, with little consideration given to the official development plans of local authorities. This silencing of local political input is extremely concerning. Additionally, it is apparent that there has been no consultation with the Dublin City Council (DCC) or South Dublin City Council (SDCC) conservation authorities regarding the potential impact of the NTA's drastic proposals on the historical heritage villages and communities of Rathgar, Terenure, Rathmines, Kimmage, and Templeogue.

Once the landscape of these historical suburbs has been altered, it will have an devastating impact on the communities which cannot be undone. I strongly urge you to reject the proposal until they have engaged in proper communication with the residents who will be affected and the relevant bodies concerned.
