

I would like to object to the proposed Templeogue /Rathfarnham to City Centre Core Bus Corridor Scheme.

I have lived in Rathmines for over 35 years and I attend mass regularly at the Mary Immaculate Refuge of Sinners Church in Rathmines.

Private vehicle access to the church will be greatly restricted under the above scheme. I have concerns as to how the proposal will impact access to the church and its car parks for parishioners attending Mass, funerals, weddings and other church events.

Access to the church from Rathmines road is of vital importance to those of us who attend mass. Many parishioners are elderly and need private vehicle transport to and from the church, this will be greatly inhibited if the above scheme goes ahead and will cause untold stress and limitations for many.

I would like if the following alterations were made to the above scheme:

That the hours of operation of the bus gate are reduced to better acknowledge the busiest hours for traffic in the area and to not be in operation when the church is in use.

I request that the hours of operation of the Bus Gate are amended to the following times:

- 6am to 9am
- 4pm to 8pm

This amendment would mean that the Bus Gate is operational for the busiest times of the day but would not be operational at quieter times of the day when Mass and other services would take place.
