



I would like to make the following observations re the Bus Connects – Templeogue to City Centre route –

In the Bus Connects proposal 2 new bus routes are to be routed onto Highfield Road, Rathgar which means that ALL vehicular traffic and buses and cycles are to use the SAME 1 lane BOTH inbound and outbound. Highfield Road is already a busy access route and the addition of buses to this route will only add to the traffic volumes and will incur delays both entering and leaving Highfield Road.

Despite requests from local residents cycle lanes have not been allowed on Highfield Road as the road is not wide enough.

Numerous cyclists already use Highfield Road on a daily basis and, importantly, to access NINE local Schools (The High School Rathgar: Gonzaga College; Alexandra College; Stratford College, Rathgar and various primary schools including Kildare Place Primary School; Scoil Bhride; Lis Na Nog; Zion Parish Primary School and Rathgar National School) and will be in the same lane as both buses and cars! This is completely unsafe – for all road users!

Rathgar Road will have designated inbound and outbound cycle routes and the THREE specific schools that will be accessed via this route are St Louis High School, St Louis Primary School and St Marys College.

Highfield Road is HALF the width and HALF the length of Rathgar Road and the pavements on Rathgar Road are 60% wider than ALL of the pavements on Highfield Road.

Rathgar Road is designated to have 3 lanes inbound only (cycles, buses and cars) and 2 lanes outbound only (cycles and buses) and this will mean that the majority of outbound traffic wishing to access Rathgar village/Terenure will now be routed up ONE lane on Highfield Road.

The removal of the ban on no right hand turn from the Upper Rathmines Road to Highfield Road will significantly increase the volume of outbound traffic onto the outbound lane on Highfield Road and the removal of the ban on no right hand turn from Highfield Road onto Rathgar Road will cause additional delays at this junction and create traffic backlogs.

ChristChurch Rathgar operates a Meals On Wheels service for the community. There will be delays accessing the main Church car park in order to collect the food items and delays on delivering the hot food as all vehicular traffic will be routed inbound on Rathgar Road whereas the majority of recipients are located in the opposite direction.
