



Dear Sir/Madam

We are writing to set out our observations and objections in relation to that part of the scheme that is planned to be constructed adjacent to our home on Swords Road in Whitehall.

We have lived at this address since 1989 and during this time we endured the construction of the Dublin Port Tunnel which caused residents of this road huge inconvenience, disruption, dirt, noise and stress. During consultation with DCC and the Tunnel Contractors, in the construction phase of the Tunnel Project, it was agreed to plant trees and shrubs to protect residences in an attempt to minimise noise, dust and as a barrier to the traffic on the N1. These trees and shrubs have greatly helped keep dirt and noise from the N1 at an acceptable level although not eliminating these entirely.

It is now intended to remove mature trees and in effect remove part of this barrier.

We are angry and disgusted to find out that a significant number of these trees and shrubs are proposed to be removed to accommodate a cycle lane which it is intended to construct as part of the Bus Connects Scheme. It has taken almost 20 years for these trees and shrubs to reach maturity and now we understand that during the Bus Connects construction many of these trees and shrubs will be removed. It is not acceptable to promise to replant trees which will not mature during our lifetime. We vehemently oppose this proposal.

In relation to the cycle lane, we are **opposed** to the location of this on our road as it is our experience that many cyclists currently use the **footpath** instead of the road. They cycle on the footpath at speed thereby creating a risk to pedestrians and residents attempting to exit driveways in their cars. This is a mixed area with many elderly people and families with young children. The cyclists have no regard for other road users or those living on the road and do not adhere to the Rules of the Road.

The proposed cycle lane, as far as we can ascertain, would be situated on the Swords Road, parallel to the N1- in front of our property. We are concerned that if the proposed cycle lane is to be routed through shrubbery it would create an opportunity for anti-social behaviour and illegal dumping. We are asking you to reconsider the siting of this Cycle Lane and examine the feasibility of using part of the lands in Ellenfeld Park to accommodate this.
