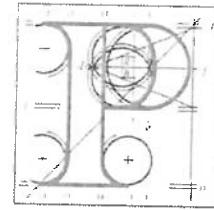

Dear Sir/Madam,

I live at 28
Greenmount Close, Harold's Cross which
is my permanent address. As you
are doubtless aware Harold's Cross
road is a main artery for traffic
in and out of the city of Dublin
and is a very busy road. Noise
generated by the traffic using the

artery is a serious problem for me and I am aware for other people too. I have lived with the serious nuisance of this traffic noise for a number of years and there is no doubt that the proposed Bus Corridor scheme will exacerbate this situation. The increase in noise pollution will affect my health adversely and I am also aware there will be a section of the frontage of our garden to be taken for the widening of the road which will bring the traffic nearer to my windows and that includes people traffic too, which in turn will create even more noise.

This traffic noise has an adverse affect on my health. I find it extremely difficult to sleep at night and I have bouts of disturbed sleep due to the traffic

noise. There is also traffic Air pollution. I am aware that the bus stop outside our complex is to be removed. As I have a disability and the fact there are other people with disabilities in the complex this will have an adverse affect on me and other people living in the complex as we will have to walk much further to another bus stop.

This will all have an affect on my health and for that reason I object in the strongest possible terms to the Core Bus Corridor scheme and all the associated builder works. I reserve the right to protect my health against the searage of Air and noise pollution.
