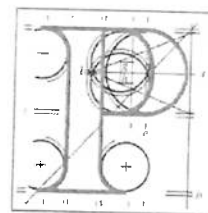

An Bord Pleanála has received your recent submission in relation to the above-mentioned proposed road development and will take it into consideration in its determination of the matter.


Please note that the proposed road development shall not be carried out unless the Board has approved it or approved it with modifications.
