



The premise for this change is bus connects (a supposed improvement scheme for Dublin). This scheme as it impacts the green verge adjoining South Park makes absolutely no sense to me. why this change is being proposed. Indeed changes proposed are extremely concerning for my family and I. My husband and I have four children, two of whom are 10 and 6. This is a safe, secure and quiet road, where our children can play freely at the top of the cul de sac with their friends.

The imposition of a lane at the top of the road will take this benefit away from our children. I also have concerns that people will use our road as a pass through to other roads, eg Clonkeen road, on scooters etc making the road no longer a safe place for our children. We bought our house knowing that the road is a cul de sac. At no time were we consulted on any of the changes happening. Our area is being changed significantly already with plans for the N11, but I never envisaged that our road would have to change to accommodate a laneway. It makes no sense and it is very unclear what benefit if any will be achieved by this change.

While the benefits are unclear and I would say do not exist, particularly given the existing laneway in Beechpark,. The disadvantages for residents here are very clear.

- (i) The addition of a laneway to what is a quiet cul de sac will create a less safe and less secure place to live for all residents. Our children for example will no longer be able to play with their friends on the road (as it will no longer be safe) and the road will be used as a through way, twenty four seven increasing the number of people going up and down our street.
- (ii) People will use our road for parking, creating difficulties for residents getting in and out of their houses.

There is an existing laneway out to the N11 in Beech Park. That lane has been there for many years. There is no need for two lanes. If changes are being proposed to the existing lane then these have also not been consulted on and I would be very concerned about the lack of transparency about changes as fundamental as this for our neighbourhood.

5. Grounds

I am a resident of 104 South Park the CPO and planned development at the top of my road (addition of a laneway) as described in Section 5 will have serious impacts for my family. Further at no point were we consulted on these changes and our acquisition of our property was made knowing that the road we live on is a culdesac providing a safe and secure environment for our children.
