



The proposed CPO of lands at Woodbank involves a significant loss of mature trees. Dublin Road is Shankill is currently a moderately busy, tree-lined suburban road. The road has the Loughlinstown ambulance dispatch centre and has a very frequent bus service at present resulting in already significant traffic noise. The mature trees along the road, and in particular along the property boundary at Woodbank, provide significant noise abatement for residents in both Woodbank and in the Stonebridge development which is behind Woodbank.

The proposed Bus Connects Corridor will not result in any significant change in the frequency with the E1 replacing the existing 145 and 155 services. Currently, there is zero traffic congestion in Shankill. Removing mature trees to add unnecessary bus lanes would be turning what is a suburban village into simply another urban highway seems to be complete overkill in this regards. Plans already exist to add bus lanes to the N11/M11 which bypasses Shankill. Adding bus lanes through Shankill will only encourage commuter traffic to "rat-run" through Shankill village and divert car traffic away from the M11/N11 and instead into a quiet village environment.

Whilst we welcome the overall Bus Connects project, and the proposed improvements in service that will come with the project, we cannot support elements of the plan that will destroy the village of Shankill and the amenity
