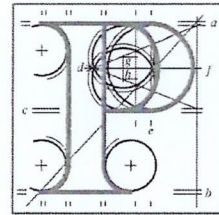

To whom it may concern,

I write in objection to the proposed wall opening opposite number 34 Shanganagh Vale. The grounds of my objection are;

Safety – The location of the wall will have a road crossing on a dangerous bend within the road. There are two Montessori schools in the estate, one at number 33 next door and one at the back of the estate. It is not a point in the road where one would encourage children to cross the road, even with an adult.

Security – The opening of the wall will leave the estate and our property very exposed to vandalism, youth disorder, theft and antisocial behaviour, all of which were commonplace prior to the wall being erected. We are well sheltered currently and enjoy a peaceful existence.

Poor use of taxpayer money – I object to taxpayer money being used to support a poorly conceived intervention like this. Any intervention should be trying to solve a problem...no problem exists here, in fact problems are likely to be created by the intervention. The cost of completing the intervention and the associated costs is a waste of taxpayer money.

Integrity – The estate did not ask for this opening, we have been living peacefully without an opening and don't want one now.

I leave you with the above and trust they will be given consideration.
