

Re. Planned Bus connect route through Shankill

We, eighteen worried residents of Corbawn in Shankill from eleven households, wish to express our concerns about the planned bus connect changes to the village of Shankill and the residency of Corbawn.

The traffic has always been fluid through Shankill thanks to the roundabout at St.Anne's church. The abolishment of this charming roundabout and replacement by additional sets of highly disruptive traffic lights will neither improve the speed of the buses nor help the residents of Corbawn and Shankill and other commuters circulating in and out of Corbawn and through Shankill. On the contrary, it will lead to more traffic jams filled with buses back to back. Also, this is a loss of beautiful nature including the loss 420 healthy trees - most of them over 100 years old - that a lot of care has been put in over the years which goes totally against the DunLaoghaire-Rathdown "Tree strategy 2023-2030". This will be a big loss of more ancient heritage and to the preservation of nature.

Additionally, cycle facilities are not even going to be continuous.

The proposed change to Shankill village is going to be disastrous for the future with no major benefit to bus times and the bus network.

Please make an alternative plan before it's too late!!
