



This submission is made in objection to the Core Bus Corridor to Dublin city centre, coming from Bray, and in particular to that part concerning the N11 adjoining Patrician Villas. I wish to raise a number of concerns which I believe warrant addressing by the applicants and An Bord Pleanala.

The relocation of the bus stop: It is intended to relocate the present bus stop (4571) from it's location at the top of Stillorgan Grove to a point further north, directly adjoining Patrician Villas. No clear reason is given for this relocation and it is submitted that the relocation will inconvenience both residents of Patrician Villas and commuters using the bus stop. If this change is to proceed a compelling reason should be provided for same.

Further delays to Traffic: It is intended that this new bus stop will be served by a new crossing on the N11 at this point. As this is currently a junction not 100 yards south this will result in the build up of traffic along the N11 emitting files as it attempts to pass two traffic sequences in quick succession. This makes no sense from any point of view - Drivers will be inconvenienced while those of us living beside the intended development will be subject to cars loitering

for longer with the resultant emissions this brings. Individuals with respiratory issues will be subject to further discomfort and negative health outcomes.

Tree Removal: As part of the development it is indicated that a large number of mature/semi mature trees will be removed. As things stand these trees act as a sound barrier sparing residents the worst of the noise from the N11 and acting as a filter for emissions. The removal of these trees will increase noise levels and emissions, this further exacerbated by the above mentioned double junction that is proposed. Additionally, the removal of mature trees and the surrounding bush will have a negative impact on the wildlife that resides there, most notably the foxes that are a regular feature of the area, but also the countless insects and birds that use the area for shelter and feeding.

Congestion: It would not be unwarranted to expect that Patrician Villas would be used as a 'park and ride' type facility for some commuters intending to use the new bus corridor. Taken too far this may see the roads herein clogged up with cars for large parts of the day, impeding residents and potentially blocking access for emergency vehicles.

The Residents Association has done great work in recent times improving Patrician Villas. All these efforts are now threatened to be undone by this proposed development. It is therefore requested that the matters above are given consideration before a decision is reached,
