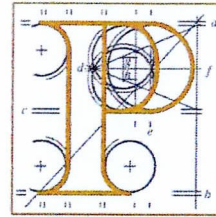


Re Bray to City Centre Core Bus Corridor Scheme
