

Compulsory Purchase Order Ref. 1039 (Castle Street, Bray)

To whom it may concern,

I, Peadar Smyth, owner of Four Star Pizza Bray wish to lodge a submission re the proposed bus corridor by NTA through Castle Street, Bray, Co.Wicklow for the following reasons:

- Business survival: We are a thriving food delivery business and on most nights will have up to 10 delivery drivers and take away customers. By taking our car parking spaces away means we can't function as a business.
- Uncertainty on timing: When works start the planning states that the whole car park
  will be taken over for the time of the roadworks, meaning no provision of
  customer/staff access. How long will it take to complete? Our business depends on
  short term car parking for pick up and delivery.
- 3. No clarity on alternative parking for staff & customers: Where is the provision of car parking spaces for the above? There is a vacant site next door which would ease the situation. If they can make a CPO for several business spaces they can do the same also with this site to ensure the survival of the existing business.
- 4. Lack of consideration for local business community: On the plans there is no provision for any loading bays for the businesses on the left hand side of Castle Street (heading towards Main Street, Bray). At present there are 18 commercial units potentially impacted by this, indicating that there is no appetite to engage with the thriving business community in Castle Street. These cannot be ignored. The only way of getting deliveries to these premises will be by trucks parking on the bus corridor. Nothing on the plans submitted indicate otherwise.
- 5. Benefits of the bus corridor are unclear: Can you please explain the difference between a bus corridor and a bus lane? We already have a bus lane on Castle Street. Why the need for all this expense and disruption and potential loss of jobs?
- 6. No clear link with planned future developments in the area: The most frustrating thing from the whole exercise is the bus corridor will come to an abrupt end at the Fran O'Toole bridge (bottom of Bray Main Street). Until such a time the widening of the bridge the whole exercise defeats the purpose and just creates a bottleneck on Castle Street. NTA states that their only brief is to the start of the bridge. Any works to the bridge will be part of other works. In other words it's not their problem. It will be the problem for business/residents when they are left to deal with this upheaval.
- 7. Lack of consistency in traffic planning: The bus corridor on the main St has been closed and made a bicycle lane. Where is the free flow of traffic?

As you can see there has been zero consultation with the business community & very limited information sharing from the NTA. We as a business going forward need a lot of questions answered so we can make informed decisions.

I would like to request an oral hearing to get my concerns across.
