

Re Bus Corridor-Bray to Shankill

It is proposed to CPO my front garden to facilitate the planned bus corridor. While I have received a drawing showing 2 lines on a on a map I have not been informed of how many sq meters I am likely to lose. I would have thought that this information should be provided as a matter of course. I am also upset as I will lose 8 or more mature trees on the property. The removal of the 200+ year granite stone boundary wall is also lamentable. The wall includes the outline of a pedestrian entrance for access to a well on my property which provided water to locals before the public water supply and reservoir was built in Roundwood in the late 1800s. This important piece of history which at present can be seen on my boundary wall will be lost forever.

The vast majority of the Shankill community are opposed to the plan as it will adversely affect the village as we have known it for the last 20 + years (since the N11 bypass was opened). The study claims that the journey to the city will be faster by just over 5 minutes and the opposite journey by 7 + minutes. This saving does not justify the disruption to the community. Furthermore, the existing bus service will be reduced. Bus 155 is to be replaced by another less frequent service. This is not in the best interest of the residents of Shankill.

I have carefully examined the cycle route proposals and quite frankly they make little sense and they will not facilitate cyclist travelling to or from Bray through Shankill. Expecting cyclists to change over and back across a main road can only be described as dangerous. The provision of a double cycle lane for a short distance outside my property will seriously impede my access access and egress and will also be dangerous for both cyclists and pedestrians.

Why this plan is proceeding when Wicklow Co.Co. are planning to build bus lanes on both carriageways of the M11 defies logic. The greatest hold up in the bus route between Bray and Loughlinstown is at the bridge over the river Dargle in Bray and the Bus Connect proposal will not ease this bottleneck.

The scheme has no support locally and should be abandoned before the local environment is permanently damaged.
