

APPLICATION TO AN BORD PLEANÁLA FOR SUBSTITUTE CONSENT

SITE NOTICE

I, Olive Faherty (nee Flaherty), intend to apply for SUBSTITUTE CONSENT for development at this site address: An Furmina, Inisheer, Aran Islands, Co. Galway.

The development consists of: An existing 4 no. bedroom residential dwelling with a ridge height of c. 7.9m and gross floor space of 244m², which represents a change of house type/design from that previously granted permission under Galway County Council Planning Register Reference Number 15/1313, and all associated site development works.

The application is accompanied by a Remedial Natura Impact Statement (NIS).

Submissions or observations may be made on the application, and/or Remedial NIS, to An Bord Pleanála, Marlborough Street, Dublin 1, without charge. Submissions or observations must be in writing and made within the period of 5 weeks beginning on the date of receipt of the application by An Bord Pleanála and such submissions and observations will be considered by An Bord Pleanála in making a decision on the application. An Bord Pleanála may grant the consent subject to or without conditions, or may refuse to grant it. The application for consent and Remedial NIS may be inspected, or purchased at a fee not exceeding the reasonable cost of making a copy, at the offices of An Bord Pleanála, or the relevant planning authority [Galway County Council] during public opening hours.

Tá sé ar intinn agamsa, Olive Uí Fhlatharta (née Ní Fhlatharta) cur isteach ar cheadúnas ionadach ar son forbairt ag seoladh an suímh seo: Baile an Fhormna, Inis Oírr, Oileáin Árann, Co. na Gaillimhe.

San fhobraíocht seo tá: teach cónaithe le 4 sheomra codlata ann cheanna féin, le cíor mhullaigh ar airde c. 7.9m agus spás urláir comhlán 244m², atá mar ionadaí athrú/dearadh tigh a bhí ceadúnas faigthe cheanna féin faoi Chláir Pleanála Chomhairle Chondae an Gaillimhe Uimhir thagartha 15/1313, agus ag saothair forbartha an suíomh seo a bhaineann leis.

Tá Ráiteas Feabhas i dtaobh Tionchar an Nádúir ag gabháil leis an iarratas seo.
