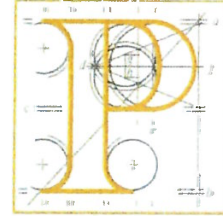

**Re:** Application for Substitute Consent for the continuation of existing quarrying works, consisting of the extraction and grading of stone for the building industry, and all associated site development works. Drumbeagh, Mountcharles, Co. Donegal.

Dear Sir / Madam,

I have been asked by An Bord Pleanála to refer to the above-mentioned application for substitute consent.

The Board has examined the application and is of the opinion that certain information is necessary for the purpose of enabling it to determine the application. Following consideration of this application for substitute consent under section 177E of the Act, the Board considers that the application does not comply with the requirements of 177E(2)(f) as prescribed under section 177N (2)(c) of the Act requiring the applicant to publish a specified notice or notices, having regard to the provisions of articles 224 and 225 of the Planning and Development Regulations 2001, as amended and in, particular, to the amendment of Article 231 of the Principal Regulations as set out in the Planning and Development (Amendment) (No. 4) Regulations 2023, substituting "8 weeks " for "5 weeks". In this case, the newspaper notice and site notice did not substitute "8 weeks " for "5 weeks".

In accordance with section 132 of the Planning and Development Act 2000 (as amended) you are required to submit, on or before **28th August 2024**, the following information:

- **Revised public notices reflecting eight weeks for the public to make submissions or observations to the Board regarding the submission of an EIAR.**

If the information required is not received before the end of the specified period, the Board will dismiss or otherwise determine the application without further notice to you in accordance with section 133 of the 2000 Act. Your submission in response to this notice must be received by the Board not later than **5.30 p.m. on the date specified above.**
