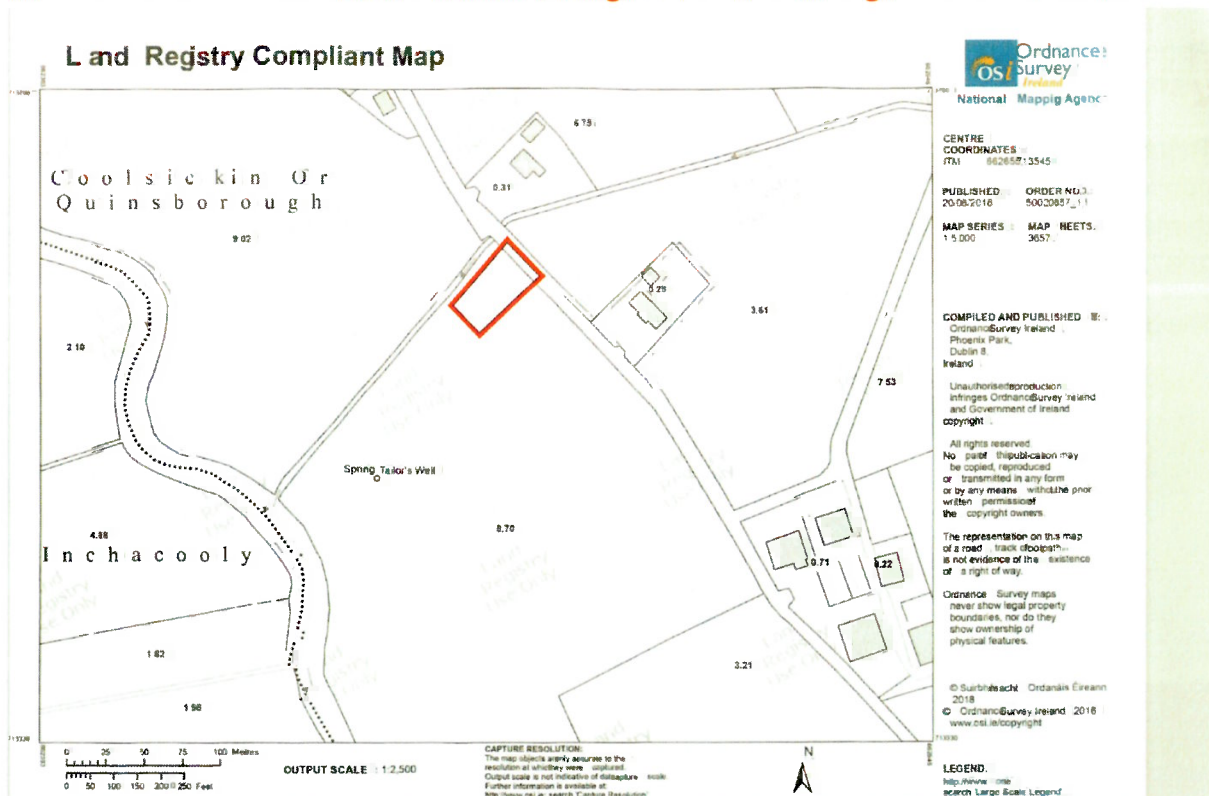
There are nine million gallons of water in the Quarry void, the subject of a Bison Quarries application. In their remedial screening document with supporting documents, they demonstrate a clear intent to follow the same path of extracting water as was done illegally in 2007.

The photograph below was taken on Friday, June 13th, 2005, of the Quarry as it is now.



Our farm at Quinnsboro is the last point of discharge in their screening plan. The owners, Larry McCormack and Mary Fanning McCormack, give no permission, licence or consent for Bison Quarries LTD to feed or discharge any wastewater from the Quarry, the subject of

this substitute consent A BP Nb. 322432 through our land for the rough hour and for the through streams on our land.



It is clear, in the case of Bison Quarries, that they intend to pump onto the Grand Canal bank, which is the property of Waterways Ireland. Feed this massive water volume up and into what they describe as a 'run-off ditch' off the Grand Canal bank. This is not their property; it belongs to Waterways Ireland, and the towpath is now part of the Blueway.

- Please note the maps from their application, which show this direct route.



Below are photographs collated in 2007 of the then rogue operators illegally pumping large volumes of water onto the canal bank from the quarry, the subject of the application. It was the source of news reports in the local and national media. Habitats were destroyed. Damage was done to the local water supply when spring wells were exposed and the water was depleted in farms and households in the area.







Feed



In 2007, the water was fed under the culvert stream at the canal, not their property as before and is so marked on their current screening application for substitute consent. See photographs

taken in 2007 of this culvert stream as marked in their remedial screening document .





The massive volumes of water were then fed through streams up to Quinnsboro, across Mick McCormack's land, and discharged across the road to Larry McCormack's land, through a stream, and into the Figle without consent. See maps of our land below.
