Substitute Consent Application under the provisions of Section 177E of the Planning Re: and Development Act 2000 (as amended)

Subject: Deep Water Quay development at Ros an Mhíl, Co. Galway.

Dear Sir/Madam

MWP has been appointed by the Department of Agricultural, Food and the Marine (DAFM) ('the Applicant') to prepare and submit an application, on its behalf, for substitute consent to An Comisiuín Pleanála in order to regularise the planning status of the incomplete Deep Water Quay development located at Ros an Mhíl Fishery Harbour Centre, Ros an Mhíl, Co. Galway.

The development for which substitute consent is being sought, consists of development carried out from 11th July 2023 to 20th May 2024 comprising drilling, blasting and dredging of approximately 25,000m3 of seabed rock within the quay wall trench, berthing pocket and adjacent channel; filling and dredging of temporary blasting platforms; infilling/reclamation works of an area of 0.12ha; placement of 48 linear metres of pairs of ground beams for a Quay Wall foundation and associated temporary construction works; and associated construction management works; all undertaken for the purposes of construction of a Deep Water Quay development which had previously been granted permission by Galway County Council under Planning Ref 17/967.
