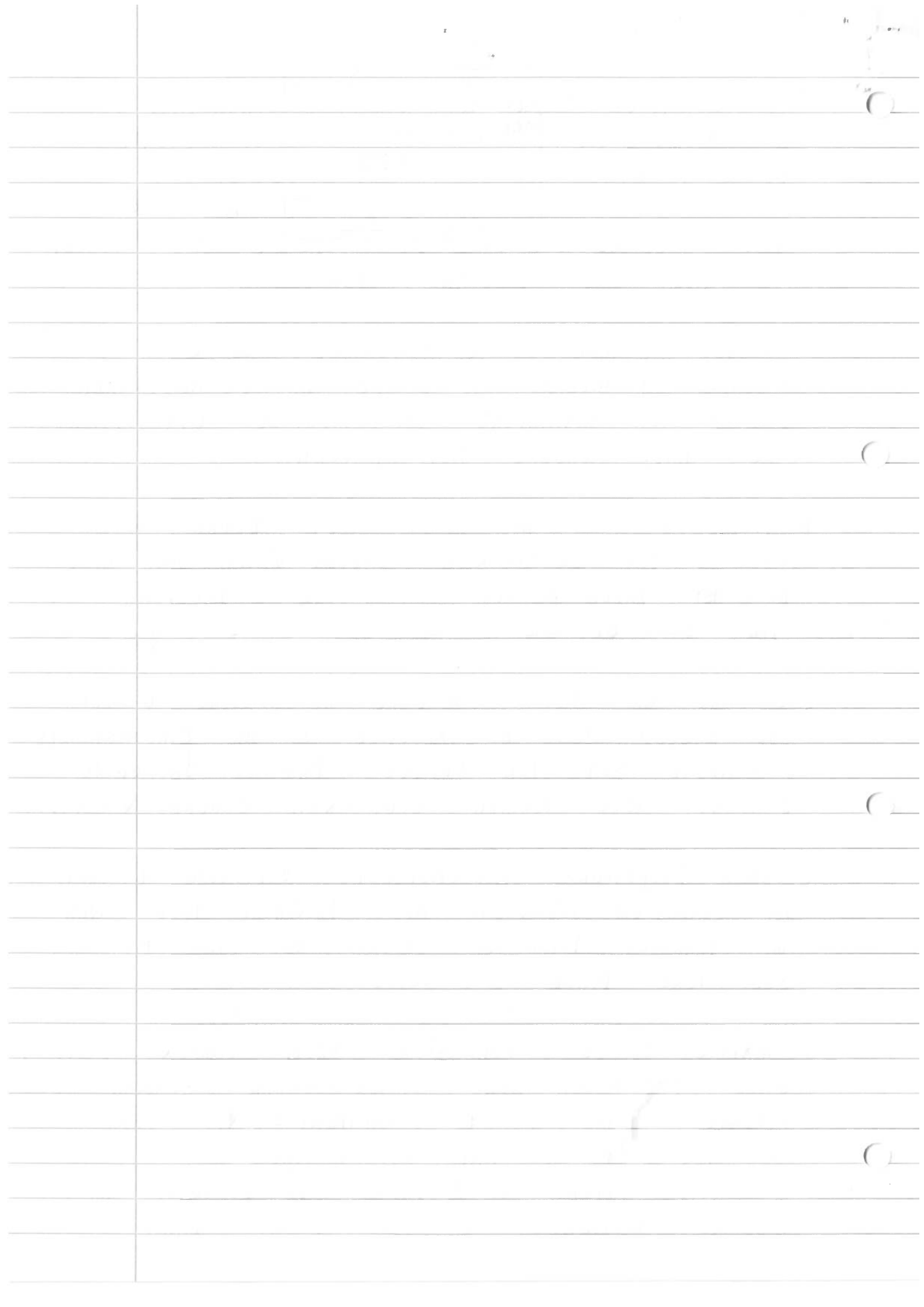

- A. EXISTING QUARRY IS UN-AUTHORIZED AND GIVEN PLANNING PERMISSION TO EXTEND AN UN-AUTHORIZED QUARRY IS REWARDING UN-AUTHORIZED DEVELOPMENT AND THIS SHOULD NOT HAPPEN.
- B. EXTRACTION TO AT LEAST 20M DEPTH WILL MOST LIKELY CONTAMINATE GROUND-WATER AND ALSO NEAR-BY RIVER BARROW WHICH IS A EUROPEAN SITE - SAC - 002162.
- C. BLASTING WAS NEVER ALLOWED AT EXISTING QUARRY AND SHOULD NOT BE ALLOWED IN ANY CIRCUMSTANCES AT ABOVE SITE FOR OBVIOUS REASONS, INCLUDING BLASTING WILL FURTHER CONTAMINATE GROUND-WATER.
- D. UNDER EXCEPTIONAL CIRCUMSTANCES - SUBSTITUTE CONSENT, AN COIMISIÚN PLEANÁLA ARE PREVENTED FROM GIVEN THIS PLANNING PERMISSION - PLEASE SEE ALL MY SUBMISSIONS DATED 2-2-2026.

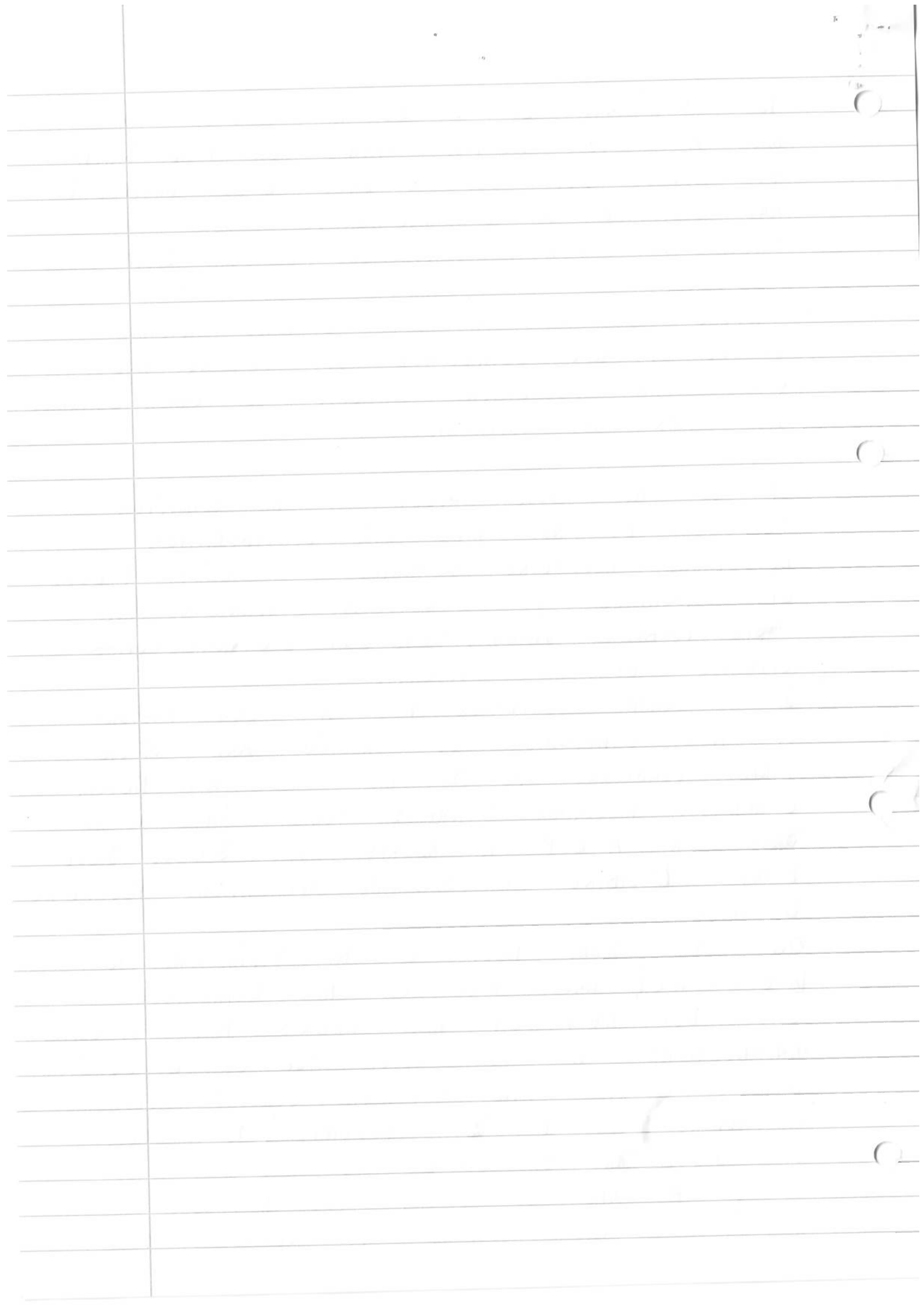

It is NOT GOOD ENOUGH THAT AN COMISION PLEANÁLA DO NOT TAKE INTO CONSIDERATION, ESPECIALLY REGARDING QUARRIES, THE TRACK RECORD OF COMPLIANCE OF CONDITIONS = PLANNING AND WASTE PERMIT ATTACHED TO ALL QUARRY SITES OPERATED BY THE APPLICANTS

IF A QUARRY OPERATOR HAS A LONG HISTORY OF NON-COMPLIANCE OF PLANNING AND WASTE PERMIT CONDITIONS, AS IS THE CASE WITH MILFORD QUARRIES = KILCARRIG QUARRIES. SURELY THERE IS AN ONUS ON A.C.P. TO ADDRESS THIS SERIOUS ISSUE BEFORE DECIDING ANY PLANNING APPLICATIONS REGARDING QUARRIES.

OVER THE YEARS MOST OF MY SUBMISSIONS TO [A.B.P. = A.C.P.] HAVE BEEN ON NON COMPLIANCE ISSUES, BUT A.B.P. = A.C.P.
