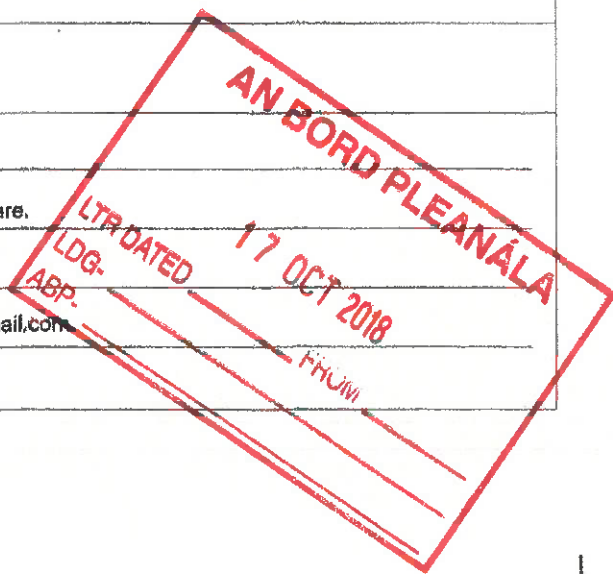


**REQUEST FOR A DECLARATION ON DEVELOPMENT AND EXEMPTED DEVELOPMENT
(Section 5 of the Planning & Development Act 2000 (as amended))**

Sample Question: *Is the construction of a shed at 1 Main St., Ennis development and if so is it exempted development?*

Is the change of use from use as a hotel reception area to use as a cafeteria at the Queens Hotel, Abbey St., Ennis, development and if so is it exempted development ?

(b) Provide a full description of the question/matter/subject which arises wherein a declaration of the question is sought.

The Queens Hotel has recently reorganised its internal arrangement whereby, inter alia, the area used as hotel reception on the ground floor has been adjusted to provide for seated cafeteria type use. The reception desk has been relocated to the first floor within the hotel premises and is accessible from the cafeteria area. It should be borne in mind that the reception area when located on the ground floor did accommodate seating and was also frequently used for the service of food, light snacks et cetera. As in any hotel premises there are a variety of locations in which meals of a variety of types are served. The use of the area formerly used for reception purposes as an area for serving cafeteria type meals does not have any impact on likely footfall, extent of deliveries or delivery times. Any increase in footfall which may arise would be as a result of more successful management of the premises rather than any change of use. While the term "change of use" is used above, it does not appear that a "material change of use" has taken place.

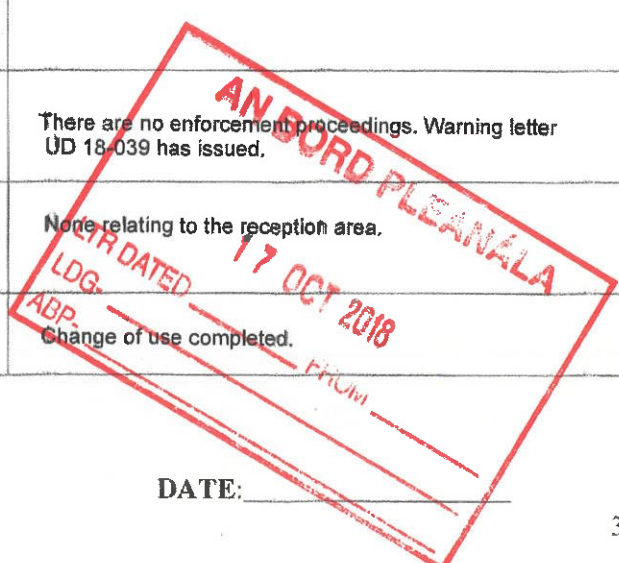
We seek a declaration on this matter from the planning authority including reasons for the planning authority's decision.

GUIDANCE NOTES

This following are non-statutory advice notes prepared by Clare County Council for the purpose of advising people what information is required for a decision to be made under Section 5 by the Planning Authority

- (i) The request for a declaration under Section 5 must be accompanied by 2 copies of site location map based on the Ordnance Survey map for the area of a scale not less than 1:1000 in urban areas and 1:2500 in rural areas and should clearly identify the site in question.
- (ii) The request for a declaration under Section 5 must be accompanied by the required fee of €80.00.
- (iii) If submitting any additional plans/reports etc. as part of the request for a declaration, please submit 2 copies.
- (iv) The request for a declaration should be sent to the following address:
