

The Queens Hotel has recently reorganised its internal arrangement whereby, inter alia, the area used as hotel reception

the first floor within the hotel premises and is accessible from the cafeteria area. It should be borne in mind that the reception					
area when located on the ground floor did accommodate seating and was also frequently used for the service of food,					
light snacks at cetera. As in any hotel premises there are a variety of locations in which meals of a variety of types are					
served. The use of the area formerly used for reception purposes as an area for serving cafeteria type meals does not have					
any impact on likely footfall, extent of deliveries or delivery times. Any increase in footfall which may arise would be as a					
result of more successful management of the premises rather than any change of use. While the term "change of use" is					
used above, it does not appear that a "material change of use" has taken place.

- (ii) The request for a declaration under Section 5 must be accompanied by the required fee of €80.00.
- (iii) If submitting any additional plans/reports etc. as part of the request for a declaration, please submit 2 copies.
