I refer to your application for a Section 5 Declaration received on 29th January, 2019 in relation to the following proposed works:-

Operation of a Toy Shop in a retail warehouse in a bulky goods retail park at World of Wonder, Unit 3, Limerick Road, Shesheraghkeale, Nenagh, Co. Tipperary.

WHEREAS a question has arisen as to whether the operation of a toy shop in a retail warehouse in a bulky goods retail park is development and if so is it exempted development at World of Wonder, Unit 3, Limerick Road, Shesheraghkeale, Nenagh, Co. Tipperary.

AND WHEREAS Tipperary County Council, in considering this referral, had regard particularly to -

- Sections 2 and 3 of the Planning and Development Act, 2000, as amended
- Planning Register Reference N32/4101 (03/52/4101)
- Retail Planning Guidelines definition of "Bulky Goods"
- The 1st occupation of Unit 3 for the sale of toys

AND WHEREAS Tipperary County Council has concluded that – The operation of Unit 3 as a toy shop is not development as set out under Section 3 of the Planning and Development Act 2000, as amended.

NOW WHEREAS Tipperary County Council, in exercise of the powers conferred on it by section 5(2)(a) of the Planning and Development Act 2000, as amended, it is hereby decided that the operation of Unit 3 at Nenagh Retail Park, Limerick Road, Nenagh, Co. Tipperary as a toy shop is not development.
