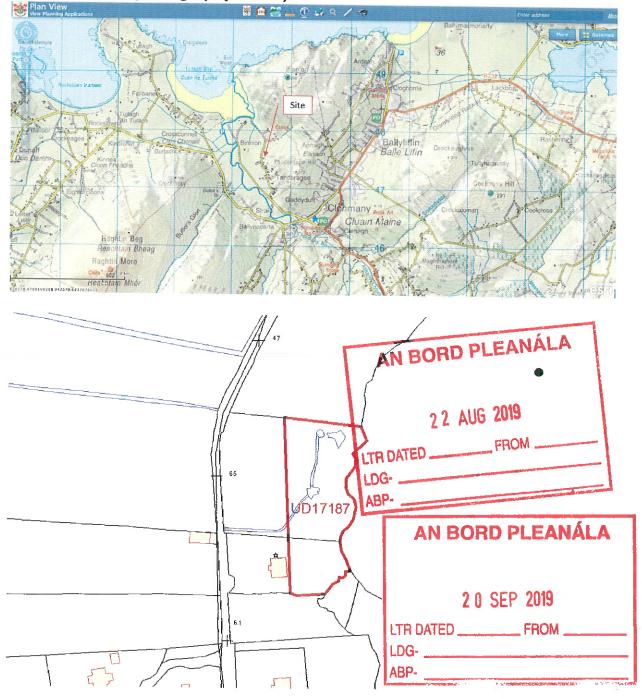

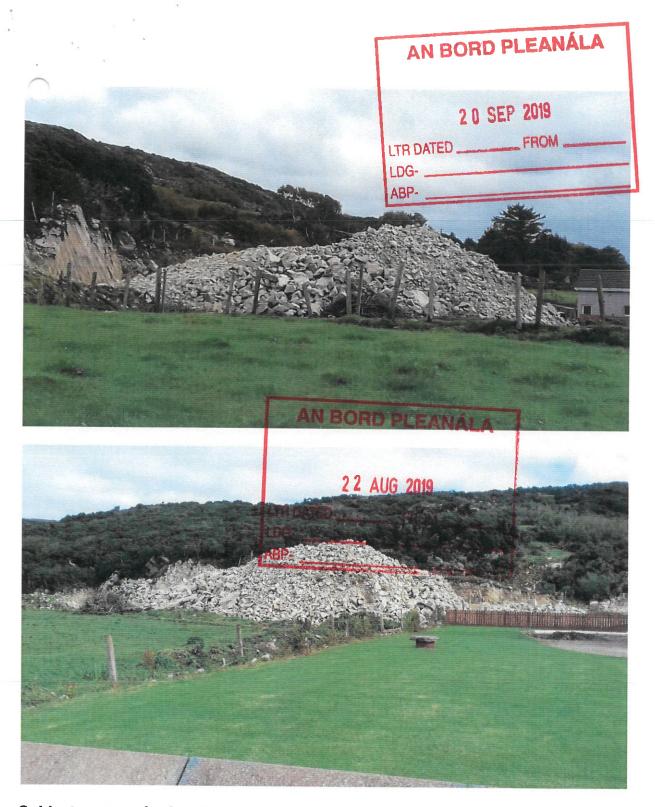

In their submission to the authority of the 04/02/19 the developer contended that the development in question is exempted development under Article 8C of the Planning and Development Regulations 2001(as amended) namely:

Land reclamation works (other than reclamation of wetlands) consisting of recontouring of land, including infilling of soil (but not waste material) within a farm holding, shall be exempted development.

The planning authority is of the view that the abovementioned development constitutes the quarrying of lands which, irrespective of the final purpose that the extracted material is used for, is a separate and materially different development to exempted development provided for under the abovementioned Article 8C of said regulations.

Consequently prior to hearing the planning authority is seeking confirmation from An Board Pleanala that it is development and is not exempted development.
