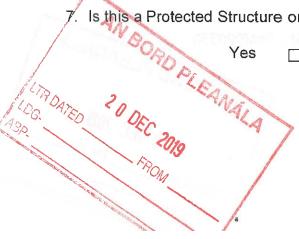

## 8. Description of Proposed Development:

Liffey Meats are currently discharging treated wastewater into the Pound
Stream at location (A) in below sketch. Liffey Meats propose piping the
treated wastewater further down the Pound stream along the North bank of
the Pound stream approximately 1.5km in a 9 inch pipe which will be buried
below the surface of the ground along the bank to the point marked (B) in the
below sketch, which is the point where the Pound stream joins the
Mountnugent river.



There is a much greater assimilative capacity at this point than where Liffey Meats are currently discharging.
