




Figure 1: Location of proposed unauthorised development (1:50,000)




Figure 2: Location of proposed unauthorised development (1:25,000)








Figure 4: Location of proposed unauthorised development (1:5,000)

"DRAINAGE OF A WETLAND HABITAT (TOTAL AREA 13 HA APPROXIMATELY) WHERE IN EXCESS OF 2 HA OF WETLAND HABITAT IS BEING AFFECTED (CF 1 (C) PART (2) SCHEDULE 5 OF THE PLANNING AND DEVELOPMENT REGULATIONS (AS AMENDED) 2001). THIS A WETLAND SITE OF HIGH BIODIVERSITY VALUE THAT IS BEING DRAINED AND FROM WHICH PEAT IS BEING EXTRACTED. THIS DEVELOPMENT AND SIMILAR DEVELOPMENTS NATIONWIDE ARE CONTRIBUTING TO THE CLIMATE AND BIODIVERSITY EMERGENCY DECLARED BY THE GOVERNMENT. THIS ACTIVITY IS HAVING A SIGNIFICANT IMPACT ON THE ENVIRONMENT. EVEN IF CONSIDERED SUB-THRESHOLD, THE IMPACT ON THE ENVIRONMENT OF THE DEVELOPMENT SHOULD REQUIRE AT MINIMUM EIAR SCREENING IN ACCORDANCE WITH THE PLANNING AND DEVELOPMENT REGULATIONS (AS AMENDED) 2001" are illustrated below.

Cavan Co. Council should be cognisant of a recent Section 5 application to Meath Co. Council concerning similar activity at a site in Meath (Planning Authority Reference Number KAS51942), which was referred to An Bord Pleanála. The Bord Order (ABP-305340-19) determined that the development identified in the Section 5 comprises Development and is not Exempt Development. Furthermore, the Bord Order (ABP-305340-19) determined that the development would require both an Environmental Impact Assessment and an Appropriate Assessment.

The area of peatland habitat currently under threat from this proposed unauthorised development, which is actively draining a wetland habitat of greater than 2 Ha and peat comprises approximately 13 Ha of habitat.
