RE: Case No. ABP -313122- 22 Illegal Quarrying/Flooding and dumping on O'Regan land at Lismaine, Jenkintown, Co. Kilkenny.

I enclose recently taken photographs showing the extent of the continual flooding of our lands in summertime.

Photo 1 Red line indicates height of water in wintertime.

Photo 2 Shows quite clearly pumping of water, end of May 2022, no rainfall for weeks

Photo 3 Cliff face of quarry just a few meters from the N77 Main road, note large cargo truck passing by, 50 feet drop down into deep water. Should an accident occur?

Photo 4 Flooding of drains at the front of my residence.

Photo 5 Taken 28/04/2021, field of left hand side now a quarry

Photo 6 My lands under water

Photo 7 Sunday independent 08/May2022. Water pumped from quarry flooding roadside drains

Photo 8 Road dry, no rainfall, yet water flows from quarry

Photo 9 Standing in my field knee deep in water from the quarry

Photo 10 My lands and septic tank flooded

Photo 11 Trying to pump floodwater out of septic tank so that family could use toilets



The Health Service Executive, Community Care HQ, James Green, Kilkenny will confirm my presence at work on that day and date.

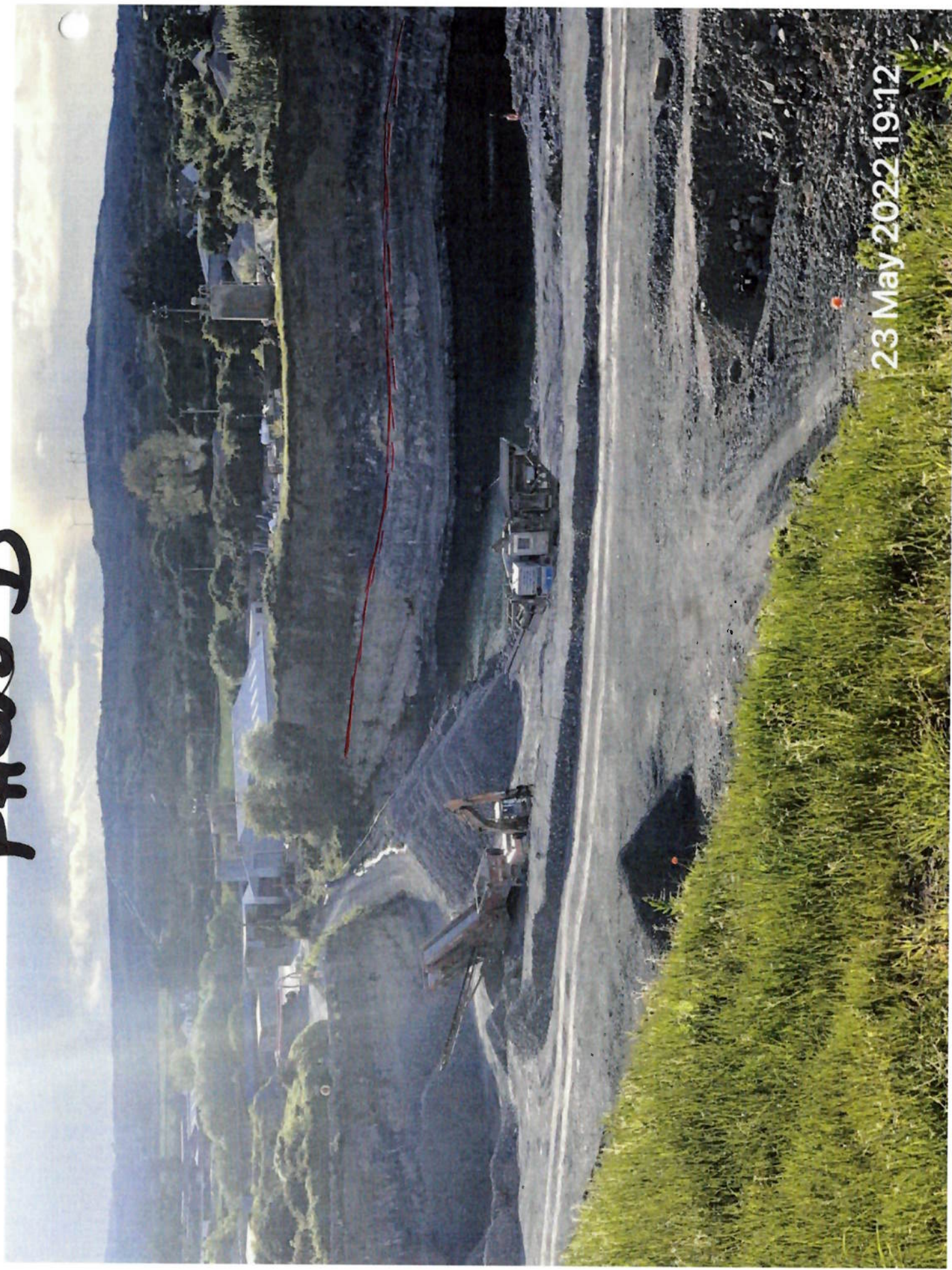
