It's unbelievable that the food safety authority are aware of this enterprise but yet to kilkenny Co Co it's a farm building???

Again trading hours are still ridiculous!! John maher was in at 6am this morning and Thomas mcguire was in shortly after him at 6.10 am.

As usual they have been given warning of an inspection and are currently altering the enterprise .

I was also speaking with Liam Stafford from coillte and again his opinion is that the illegal removal of their boundary by maguire maher enterprise is a Council matter and he has not had contact with a council member for his input regarding the illegal removal.

This is very frustrating but yet concerning, that it seems to becoming apparent that buildings can be erected and run a business from it and seemingly nothing will be done about it.. I ask again is it because peter maher is an ex employee of kilkenny Co Co that the situation is been over looked???
