

We have been reviewing the planning status of the coffee shop at The Boardwalk on the Mall, 12 The Mall, Youghal P36 VF85 with reference to Schedule 2 - Part 4 of the Planning and Development Regulations 2001-2022 - Exempted Development Classes of Use. The previous permitted use of the premises was as a funeral home permitted under P4.86 (file number 86/58004) granted by Youghal Urban District Council on 25th April 1986 and P.1/94 (file number 94/58001). In our opinion, the previous permitted use is Use Class 2(b) Professional Services other than health or medical services, where the services are provided principally to visiting members of the public (there being no specific mention of use as a funeral home within the classes of use). The current use as a café is, in our opinion, Use Class 2(c) Any Other Services where the services are provided principally to visiting members of the public (there being no specific mention of this or similar uses within the classes of use and the Class 2(c) description being open to use as a café). As change of use within Classes of Use is Exempted Development under Part 2 Exempted Development. Article 10(1) Changes of Use, of the Planning and Development Regulations 2001-2022, in our opinion, the change of use from funeral home to café is exempted development.
