- (i) *a new boundary wing walls and piers, which are in the curtilage of a protected structure (Bellamont House Ref No CN17036 and Gate Lodge Ref No CV17030),*
- (ii) *the relocation of a public access point into Bellamont Forest*
- (iii) *the fencing/enclosure of an access habitually used by the public during the 10 years preceding such enclosure for recreational purposes and use as a means of access to Dromore river and Bellamont Forest area of natural beauty and recreational utility*

*Station Road, Cootehill, Co Cavan is or is not development and is or is not exempted development.*

**In accordance with section 129 of the Planning and Development Act 2000 (as amended) we wish to submit the following points in addition to the information sent in and received by Cavan County Council on 6<sup>th</sup> August 2024;**

- The question referred to An Bord Pleanála by Cavan County Council as detailed on [www.pleanala.ie](http://www.pleanala.ie) and on documentation received by us on 3<sup>rd</sup> September 2024 differs in detail to that question which we have requested off Cavan County Council in our application received. The detail of the section 5 referral by us to Cavan County Council is as per that detailed above in italics. The referral from Cavan County Council to An Bord Pleanála fails to include the question of development of wing walls, relocation of public access point and fencing/enclosure of the access point into Bellamont Forest.
- The construction of the new wall and piers commenced in April 2024 without any consultation with any of the neighbours, the local community or any of the various groups that enjoyed this pedestrian access into the forest amenity area on a daily basis.
- The owner of Bellamont House is responsible for the construction and subsequent blocking of this pedestrian access, thus preventing the enjoyment



of the amenities of Bellamont Forest walkways and access to Dromore River for the first time in decades according to a local historian.

- Please note attached to this submission is a signed list/petition, duly witnessed by a Peace Commissioner, which sets out confirmation from members of the local community that this access has habitually been in use for at least 10 years prior to April 2024.
- The matters for referral meet the criteria that would qualify as "development" within the meaning of Section 3 of the Planning and Development Act. It has also caused a material change of use of the land within the terms of this section in that the habitual access over the land can no longer be enjoyed. The development is of such a standard that it qualifies as "works" within the meaning of section 2 of the Act.
- The development blocks pedestrians and cyclists from accessing the forest from the town centre to amenities which include the town lake; Coragh Lough and the Dromore River system which encompasses much used and loved natural looped walks around the Cootehill's town environs.
- A report of potential unauthorised development taking place at this location was sent in writing and via telephone, on numerous occasions, with Cavan County Council enforcement section throughout April and May 2024.
- It was confirmed verbally that a warning letter had issued to the landowner and a newspaper notice for a planning application was published in the Anglo Celt a few weeks later stating an application for retention and completion of the development would be lodged.
- No such application was ever lodged with Cavan County Council.
- Daily the construction works continued until such time as was evident that any such enforcement matter was not being taken seriously by either the landowner or the local authority.
- Subsequent reports and photographs showing evidence of the works continuing were sent to the enforcement section and senior management of Cavan County Council.
- No further action was taken and no written correspondence on reasons for this were provided to the complainants by the County Council.



- As recently as last week works have continued at the site on Station Road (13<sup>th</sup> September 2024) the builders were increasing the height of the wing walls at this location.

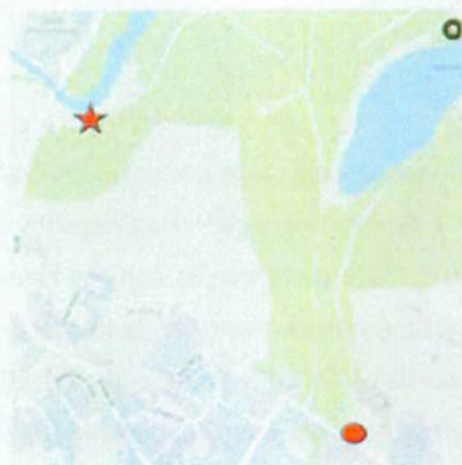
**Please Note:**

In Autumn 2023 the landowner placed large concrete blocks at the entrance point which is the subject of this referral. This action has recently been repeated at another popular pedestrian access point into Bellamont forest (at the Dromore River side). It is our fear that the landowner intends to block up another of the pedestrian accesses and we have no faith that Cavan County Council enforcement section will act in the necessary expedient fashion to prevent any unauthorised development taking place and ensuring due planning process is followed.

For this reason we would respectfully request An Bord Pleanála to consider this declaration request in a timely manner.

This 'threatening behaviour' took place in since the Section 5 declaration was submitted to Cavan County Council.


